#### Conditions

1. The applicants having age between 1-99 years old on the application date, is eligible by this insurance
2. The insurance is applicable only to those applicants residing in Thailand.
3. This insurance is not available for doctors, nurses and hospital staff
4. Physical check up is not required before application.
5. The applicants on the application date, must have a good condition of health and do not have any disabled organ, disability, congenital diseases, severe diseases, critical illness, psychotic, alcoholism and drug addict and have never had a history of severe vaccination, including allergy to the COVID-19 vaccine.
6. This insurance does not cover pre-existing conditions before application and/or any illness as a result of Corona Virus 2019 (COVID-19) and/or any complications incurred prior to the commencing date of the policy and not yet completely cured
7. This insurance allows only the COVID-19 vaccine which is registered by the Food and Drug Administration (FDA) and is vaccinated by a hospital or medical facility in Thailand.
8. This insurance is subject to a 14 days waiting period from the first commencing date of the policy.
9. "Illness with coma" means to a serious illness which the doctor concluded that there is no cure for it and/or causes death due to Coronavirus 2019 (COVID-19) infection or in case of side effects from vaccination for Coronavirus 2019 (COVID-19).
10. It is limited only One Person to One Policy.
11. The applicants on the application date, must disclose details as required by the Application Form.
12. The benefits and coverage are subject to the terms and conditions of the Personal Accident and Specific Disease for Health Insurance Policy.

#### Exclusion

The insurance by this policy does not compensate for any benefits arising from direct or indirect causes of vaccinations that have not been registered by the Food and Drug Administration (FDA).
